April 2: A Turning Point in Global Trade?

On 13 February, US President Donald Trump signed a memorandum calling for "Fair and Reciprocal Plan", instructing his advisors to calculate new tariff levels for all trading partners. In his second term, President Trump has already imposed several new tariffs, including on close allies. The Reciprocal Tariff, set to take effect on 2 April, has prompted governments to assess its potential impact and formulate strategic responses. Key trading partners such as India and Japan have already engaged in bilateral discussions with President


Reality check on BIMSTEC

Changes in the world order were unfolding well before the aid overhaul and raft of trade measures, notably tariff hikes, announced by US President Donald Trump in the first few weeks of his second innings in office. In response to the economic centre of gravity shifting unambiguously to Asia, with China at the forefront of that shift, and knowing well the clout in international relations that comes with economic strength, containing China became a major foreign policy objective of the collective West.

The "Pivot to Asia" under the Obama administration should be seen in this context. There were naturally repercussions for the rest of the world: counterweights to China were being sought in regions and subregions of the developing world. South Asia and Southeast Asia were no exception. The conflict was cast in binary terms: democracy versus authoritarianism, with the former associated with the rule of law and openness.




